## Lessons Learned: Legal Consequences of Asbestos Violations in Las Vegas

In November 2023, the construction industry faced a stark reminder of the legal consequences surrounding asbestos violations as contractors Rene Morales and Hector Vasquez, operating under Top Rank Builders, received six-month prison sentences for violating the Clean Air Act during the conversion of a Las Vegas warehouse into a marijuana cultivation facility.

The duo pleaded guilty to releasing toxic asbestos fibers into the air during the renovation, neglecting safety measures and exposing both workers and the surrounding community to hazardous asbestos particles. Documents revealed a troubling pattern of deception, as the defendants lied to investigators and attempted to conceal their actions by falsely labeling bags containing asbestos as intended for a training exercise.

United States Attorney Jason M. Frierson underscored the gravity of asbestos protocol non-compliance, emphasizing that such offenses in the District of Nevada endanger lives and will be rigorously prosecuted. Acting Special Agent in Charge Benjamin Carr highlighted the intentional violation of environmental laws and the endangerment of communities. The case was thoroughly investigated by EPA agents and the Clark County Department of Air Quality, with prosecution led by Senior Trial Attorney Cassandra Barnum and Assistant United States Attorney Jean Ripley.

This case serves as a cautionary tale, emphasizing the critical importance of thorough asbestos testing before any renovation or demolition work begins. The contractors' failure to identify and address asbestos-containing materials in the drywall and ceiling texture resulted in severe legal consequences, exposing them to six months in prison. Asbestos exposure poses significant health hazards, making it imperative for construction professionals to prioritize testing. This not only ensures the safety of workers but also helps in compliance with legal requirements, preventing legal ramifications and safeguarding the well-being of all involved parties.

# PCB Lawsuit Highlights Urgent Need for Building Material Testing and Environmental Compliance

In December 2022, The Burlington School District took legal action against Monsanto, now owned by Bayer, in a federal court, alleging that the company should bear the financial responsibility for constructing a new high school. The lawsuit, filed in U.S. District Court in Burlington, demanded compensation for the mitigation and removal of polychlorinated biphenyls (PCBs) and the estimated \$190 million cost of building a replacement school.

PCBs, a group of synthetic organic chemicals widely used until their 1970s ban due to environmental and health concerns, were found in various building materials within the school, including caulking, glazing, sealants, and flooring adhesives. The district claimed that Monsanto, responsible for a significant portion of PCBs used or stored in the United States, should be held accountable for not adequately warning them about the potential hazards.

Monsanto's legal team sought to dismiss the case, but in June 2023, U.S. District Court Judge William Sessions denied the motion, recognizing the severity of the PCB contamination at Burlington High School. This landmark decision emphasized the importance of addressing environmental hazards and holding accountable those responsible for their presence.

PCBs are persistent organic pollutants known to pose adverse effects on human health and the environment, underscoring the critical need for testing building materials. The implications are multifaceted, ranging from health hazards and environmental concerns to regulatory compliance, property value, liability, indoor air quality (IAQ), and renovation and demolition planning.
